I AM ALSO AWARE THAT SHOULD I NEED TO REFRESH MY MEMORY ON THESE RULES & REGULATIONS, I CAN FIND THEM ON THE BRICK DRAGONS SOUTH WEB SITE UNDER “FORMS”.

I ALSO UNDERSTAND AND AGREE TO THE FOLLOWING:

1. REFUNDS --
 - FULL REFUNDS PRIOR TO UNIFORM DISTRIBUTION.
 - 50% REFUNDS BETWEEN UNIFORM DISTRIBUTION AND AUGUST 15TH.
 - NO REFUNDS AFTER AUGUST 15TH.
 - ALL REFUND REQUESTS MUST BE MADE ON A REFUND REQUEST FORM AND BE SUBMITTED DIRECTLY TO THE BOARD, AND ALL UNIFORMS MUST BE RETURNED.
 - NO REFUNDS ON RAFFLE MONEY

2. VOLUNTEER/UNIFORM DEPOSIT – I UNDERSTAND THAT MY UNIFORM DEPOSIT WILL BE CASHED IF:
 - I DO NOT SIGN UP AND WORK MY DESIGNATED VOLUNTEER DUTY (I.E. SNACK STAND)
 - I DO NOT RETURN MY UNIFORM ON TIME OR MAKE ALTERNATE ARRANGEMENTS
 - I DO NOT RETURN MY UNIFORM ENTACT AND IN CLEAN CONDITION.

3. UNRETURNED UNIFORMS WILL BE SUBJECT TO LEGAL ACTION WHICH MAY INCLUDE FILING A POLICE REPORT AND/OR SMALL CLAIMS COURT ACTION IN ADDITION TO CASHING THE \$200 DEPOSIT CHECK. ALL UNIFORMS ARE THE PROPERTY OF BRICK DRAGONS SOUTH. ANY UNIFORMS NOT RETURNED BY DUE DATE; CHILD WILL BE SUBJECT TO THE LATE REGISTRATION FEE THE FOLLOWING SEASON. **UNIFORMS NOT RETURNED CLEAN WILL AUTOMATTICALLY FORFIET THE \$200 DEPOSIT CHECK.**

4. BOUNCED CHECKS WILL BE SUBJECT TO THE MAXIMUM FEES PERMITTED BY NJ LAW. PARTICIPANTS BOUNCING CHECKS MAY BE REQUIRED TO PAY CASH FOR FUTURE FEES.

PARENTAL/PARTICIPANT RULES & REGULATIONS

Welcome to the Brick Dragons South Football and Cheer Program. Football practice officially starts on or about July 25, 2011. For July and August, practice will be held Monday through Friday up to 10 hours per week. After Labor Day, practice will be limited to six hours per week.

RULES AND REGULATIONS

A child will not be allowed to participate at practice unless they meet the following criteria:

- *1. Registration fee paid in full
- *2. AYF/AYC Doctor's certificate received
- *3. Picture of player received
- *4. Copy of Birth Certificate (Original may be required by Jersey Shore League Officials).
- *5. 3 Copies of Report Card received (from previous ending school year).

IT MUST BE LEGIBLE AND HAVE ALL FOUR QUARTERS.

- *6. Player's weight is within 5 pounds of maximum permitted stripped certification weight
- 7. Parental Contract to participate signed
- 8. Volunteer/Uniform Contract is signed and \$200.00 deposit is paid
- 9. One \$80.00 raffle ticket book is purchased (Maximum 2 books per family)

*These are Jersey Shore American Youth Football regulations and they will be strictly enforced.

As a member of the Brick Dragons South Football Program, you have made a commitment to YOUR TEAM. This means that any practices, games, fund-raisers, or any activity in connection with YOUR TEAM comes first.

Each participant must always abide by the following rules:

A. ATTITUDE

- 1. Always show respect towards all coaches and fellow teammates. Pursuant to AYF, BDS, and or NJAYF Rules, any misconduct and/or extreme disciplinary problems by a player will result in a mandatory cut from the team. No refund of registration fee will be issued.
- 2. Always show respect for the uniform, the organization, and the town it represents.
- 3. Always show respect to other teams and their coaches.
- 4. Always stay together as a team, do not wander off.
- 5. Any confrontation, either verbal or physical by a parent or player, will not be allowed during any Brick Dragons South event. This could result with immediate suspension from the team.
- 6. No smoking, drugs, or use of alcohol.
- 7. No chewing gum during games or practices.
- 8. No eating during games or practices.

B. ATTENDANCE

- 1. Attendance will be taken at each practice and game. The success of the team depends on many elements. One of the most important is the team practicing together without any players being absent. Illness will be an acceptable excuse for missing practice; however, a phone call to the Head Coach prior to the start of practice is requested. A doctor's note may be required. An unexcused absence from practice can result in the loss of playing time on game day. Vacation is considered an unexcused absence.
- 2. A lateness is defined as not being on the practice field prepared to participate by the scheduled or start time it was to begin. At the discretion of the Head Coach, excessive lateness will also result in loss of playing time on game day.
- 3. It is important that all players arrive at the game field at the time designated by their Head Coach for pre-game meetings, warm ups and weigh-ins.



C. TRANSPORTATION

1. It is the responsibility of the parents to see that the player has transportation to and from all practices, games, and other activities, at the time and place designated by his Head Coach. Please be prompt. The coaches should not have to wait for any players.
2. All parents must be present at least 1/2 hour before practice ends. In case of rain, all players must report to the practice field. Parents should remain with them for at least 1/2 hour in case practice is canceled. Do not call the coach to see if practice is canceled. If the weather is bad, practice will be canceled at the field. The coaches ask for the parents' cooperation in these matters so as the coaches can also leave the practice field and go home.
3. At least one parent or guardian or adult over 21 years of age **MUST** accompany the player to and from and be present during games. (THIS IS IMPORTANT IN CASE OF INJURY).

D. APPEARANCE

1. Hair must be trimmed away from the face and short in the back (this is to insure proper fit of the helmet).
2. Jewelry of any type shall be prohibited.
3. The wearing of bandannas is prohibited.
4. Smoked or colored visors for helmets are **NOT** permitted. Also, no clear or white mouth pieces.

E. UNIFORMS

1. A player will not receive his football equipment and uniform if his registration fee is not paid, or a copy of his report card has not been handed in, work bond/uniform deposit not paid, and any required fundraiser handed in.
2. Non-detachable football cleats must be worn to all practices and games (high-top football cleats are recommended). Also, once uniforms are issued, it is the responsibility of the player to be in full uniform in order to participate in practices or games.
3. Game uniforms must never be worn to practice.
4. Each player will be responsible for the proper care of his uniform and play book. **DO NOT BLEACH** game uniforms follow the instructions inside on the manufacturer's label. Uniforms must be cleaned when they are returned at the end of the season. Players must also return playbooks at the end of the season with their uniforms. Players will be required to bring playbooks to practice, so please keep them in a safe place. **ANY PART OF THE UNIFORM THAT IS LOST OR DAMAGED MUST BE REPLACED AT YOUR EXPENSE.**
5. Uniforms must be returned the first Friday of December 2011, at the Dragon Den, Drum Point Sports Complex, 6pm – 8pm, or you forfeit your deposit. (If you cannot make this date, you must notify the football commissioner in advance to make arrangements to turn in the uniform before Dec. 2, 2011)
6. Any part of the uniform that is lost or damaged must be replaced at your expense. **APPROXIMATE COST OF TACKLE UNIFORMS ARE AS FOLLOWS:**

At anytime during the season if a player should choose not to participate, all equipment and uniforms must be returned at the next day-scheduled practice.

F. UNIFORM RETURN REQUIREMENT

At the end of the season your participant's complete uniform must be returned cleaned (do not dry clean) on the first Friday in December at the drop site, Dragon Den, Drum Point Sports Complex in order to receive your \$200.00 deposit back.



Please be aware, in addition to forfeiting your uniform deposit, you will be charged the cost of replacement for any pieces missing or abused beyond normal wear and tear. A complete list of uniform/equipment prices is stated in attached Rules and Regulations.

YOUR UNIFORM DEPOSIT WILL BE FORFEITED IF YOU DO NOT RETURN YOUR CHILD'S UNIFORM ON TIME (THE DESIGNATED RETURN DATE) OR MAKE ALTERNATE ARRANGEMENTS. UNRETURNED UNIFORMS WILL BE SUBJECT TO LEGAL ACTION WHICH MAY INCLUDE FILING A POLICE REPORT AND/OR SMALL CLAIMS COURT ACTION. ALL UNIFORMS ARE THE PROPERTY OF BRICK DRAGONS SOUTH.

G. MEDICAL, PHYSICAL, AND SCHOLASTIC FITNESS

1. Proof of medical fitness is required using the JSPWL form. A doctor's exam must be within the last five months (January 1st of the same playing year). Physical must be signed and stamped by the Doctor's office.
2. The coaching staff expects all players to be able to run four laps around the football field and have the ability to do at least (10) forty-yard wind sprints on July 25th. This means start a conditioning program in the spring. Do not wait until a week before football begins to try to get into shape. Your conditioning program should include jogging, pushups and sit-ups.
3. Proof of scholastic fitness will be required. He will not be allowed to participate for a time to be determined by the school officials and or Board Members and or Coaches.

H. FUNDRAISING

1. Brick Dragons South is funded primarily through fundraising activities; therefore, each participant **MUST** participate in all fundraisers. This includes those designated for year round even if participant is not a year round player.
2. Any cost for post-season competition will be the parent's sole responsibility to pay; however, fundraising may be made available to help recoup these costs. This does not mean if you fund raise, that you **WILL** receive repayment. It may be determined that the monies collected not be designated for individual reimbursements.
3. Each Brick Dragons South participant is required to purchase one \$80.00 book of raffle tickets. (Maximum two books per family.) Raffle money is not refundable.
4. Each participant will be expected to sell "football fundraising tickets" when the season is about to begin **IN ADDITION TO** the raffle tickets in the beginning of the year. A minimum to be determined by the Board of Directors is expected to be sold.

I. REFUNDS

ABSOLUTELY NO REFUNDS WILL BE ISSUED AFTER AUGUST 15th or the end of the second week of practice, whichever is sooner. In order to receive a refund, all equipment must be returned as well as a completed exit survey and a refund request form. The Brick Pop Warner Dragons are very interested in providing the best possible organization for the children of Brick. We are concerned when a child leaves the club and would like to know if the organization could have done something different.

The purpose of the exit survey is to solicit the opinions and/or reasons why a child leaves.

- FULL REFUNDS PRIOR TO UNIFORM DISTRIBUTION.
- 50% REFUNDS BETWEEN UNIFORM DISTRIBUTION AND AUGUST 15TH.
- NO REFUNDS AFTER AUGUST 15TH.
- ALL REFUND REQUESTS MUST BE MADE ON A REFUND REQUEST FORM AND BE SUBMITTED DIRECTLY TO THE BOARD, AND ALL UNIFORMS MUST BE RETURNED.
- NO REFUNDS ON RAFFLE MONEY

J. PARENTS PARTICIPATION

Due to insurance liability, there will be no parents allowed on the practice field. This will be strictly enforced.



You may only park in the parking lots. Your child's organization requires ALL parents to donate at least two hours of time during the season. We need cooperation from the parents in the following areas: snack stand and 50/50 ticket sellers etc. No child shall be permitted in the snack stand while parent is doing their volunteer time. No one under 18 is permitted in the snack stand by law. You will be contacted by your child's team parent who will be handling the scheduling of these assignments. If you are not contacted, it is your responsibility to contact a Brick Dragons South official to schedule you. Parental and volunteer contracts must be adhered to.

K. VOLUNTEER REQUIREMENT

The volunteer requirement can be fulfilled by donating a minimum of 2 hours (during a season) of your time in assisting on various duties. You are responsible for scheduling your own date and time. These duties include the following:

- Coaching – (Must be selected by head coach after submitting an application)
- Snack Stand - counter help at snack stand, 50/50 sales, etc.
- Team Mom – (One per team)

(You must sign the Duty Roster in the snack stand each time you work in the snack stand or on the field) It is your responsibility to make sure your time is recorded. Failure to return the uniform and participate as stated above will result in forfeiture of your uniform deposit. **YOUR VOLUNTEER DEPOSIT WILL BE FORFEITED IF YOU DO NOT SIGN UP AND WORK YOUR DESIGNATED VOLUNTEER DUTY (I.E. SNACK STAND)**

L. INSURANCE

Please remember, we will do everything we can to make this process work as smooth as possible, however, the timely filing of all injury claims is your responsibility. The Brick Dragons South has no responsibility, beyond our medical insurance policy, to pay any medical expense incurred as the result of an on-field injury.

In the event that your child is injured during a practice or game, it is important that he or she gets the appropriate medical care immediately. The Brick Dragons South carries insurance for such incidents but it is also important that you understand and follow the process of medical claim submission. If an injury does occur you should let the head coach know immediately. He will give you an accident report to fill out. Please be advised that the Pop Warner insurance is always secondary to any other insurance coverage you may have. This means that you must submit all associated medical bills to your **primary insurance carrier first**. You must pay your claims up front, and wait for reimbursement from the insurance carrier. BDS is not responsible for any portion of the bills due to an injury, including those areas not covered by your insurance.

If there are still balances due after the primary insurance makes their payments, you must submit the balance due bills along with a fully completed claim form to the Brick Dragons South 2nd Vice President. Your Head Coach or Team Parent should be able to lead you to him/her or you can contact him/her via our website, www.brickdragonssouth.com. All claims must be submitted to our insurance company within 90 days of the injury so it's important that you follow-up on all bills in a timely matter.

BRICK DRAGONS SOUTH PARENT'S CODE OF CONDUCT

IN ADDITION TO THOSE POSTED AT THE COMPLEX AND AVAILABLE FOR READING AT THE REGISTRATION TABLES:

I hereby pledge to provide positive support, attitude and encouragement for my child as he/she participates in youth sports for the BRICK DRAGONS SOUTH by agreeing to all of the following:

- · I will encourage good sportsmanship by demonstrating positive support for all players, coaches, and officials, at all times.
- · I will place the emotional and physical well being of my child ahead of my personal desire to win.
- · I will support coaches and officials working with my child to model appropriate behavior and encourage a positive and enjoyable experience for all.
- · I will demand an environment for my child free from drugs, tobacco, and alcohol, and will refrain from their use at all BRICK DRAGONS SOUTH events.
- · I will remember that youth sports are for the children and not for the adults.
- · I will do my best to make participating in BRICK DRAGONS SOUTH fun for my child.
- · I will help my child enjoy their BRICK DRAGONS SOUTH experience by being a respectful fan, assisting with coaching or volunteering as needed and whenever possible. As both a parent and a fan, I will refrain from inappropriate, threatening or violent language, gestures or behavior aimed at officials, coaches, other volunteers or children.
- · I will require my child to treat other players, coaches, fans, and officials with respect regardless of race, gender, creed, or ability.
- · In the spirit of good sportsmanship I understand that I am accountable for my own conduct as well as for those attending on my behalf.

No person or persons affiliated with the BRICK DRAGONS SOUTH may issue any statement, either written or verbal, to any newspaper, radio, television or any other media which might be interpreted to be an official statement, policy or position of this franchise or any of its affiliates without the expressed permission of the Board of Directors.

No person shall use the BRICK DRAGONS SOUTH name or logo on any article, clothing or otherwise, without prior approval of the Board of Directors.

The President shall serve as the official spokesperson for BRICK DRAGONS SOUTH, except in those instances where the President and the Board of Directors direct other personnel to handle public relations.



All parents and guardians of BRICK DRAGONS SOUTH participants are expected to adhere to this Parents Code of Conduct, AS WELL AS the posted Code of Conduct at the field. The signature below acknowledges receipt of both Code of Conducts. I understand that failure to comply with the above may result in:

- • Immediate removal from an event either by BRICK DRAGON SOUTH BOARD members or a local Police Department.
- • Depending on the severity of the offense, suspension or expulsion from all BRICK DRAGONS SOUTH activities and/or criminal prosecution.
- • For repeated violations, permanent removal from all BRICK DRAGONS SOUTH activities indefinitely.

POP WARNER TEAM CONTRACT

I (PLAYER NAME) now being a member of the Brick Dragons South program, hereby promise not to get involved with any form of tobacco products, alcohol products, or controlled dangerous substances.

I am aware that tobacco products mean the use of cigarettes, cigars, pipes, chewing tobacco or any other product made from the tobacco plant.

I am also aware that alcohol means the use of any beer, wine, liquor, whisky, or any product that contains alcohol that is controlled for sale or consumption by the Attorney General Division of Alcoholic Beverage Control.

I am further aware that controlled dangerous substances means any illegal substances such as steroids, inhalants, marijuana, crack, cocaine, amphetamines, ecstasy, GHB, or any other illegal product listed as schedule I or II of the State of New Jersey Criminal Code of Justice.

I acknowledge that if I am caught using any of the above aforementioned products that I will be subject to suspension or expulsion from any athletics now or in the future in the Township of Brick.

I agree that this is a binding contract between me and the Coach of my team or any other Assistant Coach and or Board member of the above organization.

Participation Agreement & Acknowledgement of Risk

I understand that I / my child (PLAYER NAME) participate(s) in the above program or activity through BRICK DRAGONS SOUTH at my / our own risk and responsibility. The BRICK DRAGONS SOUTH and its coaches shall be held harmless in the event of an injury.

In the event of necessity of emergency medical treatment, the Brick Township Police and First Aid will be the immediate first responders. The injured will be transported to the nearest medical facility for treatment. Parents and/or guardians or an appropriately designated emergency contact will be advised.

POST SEASON RESPONSIBILITIES

I understand Post-Season playoff and championship games are included in the football season and I will follow all of the rules and regulations, attend all practices and games. Any costs for competition will be the parent's sole responsibility to pay, however fund-raising may be made available to help recoup these costs. This does not mean if you fund raise, that you WILL receive repayment. It may be determined that the monies collected not be designated for individual reimbursements.
